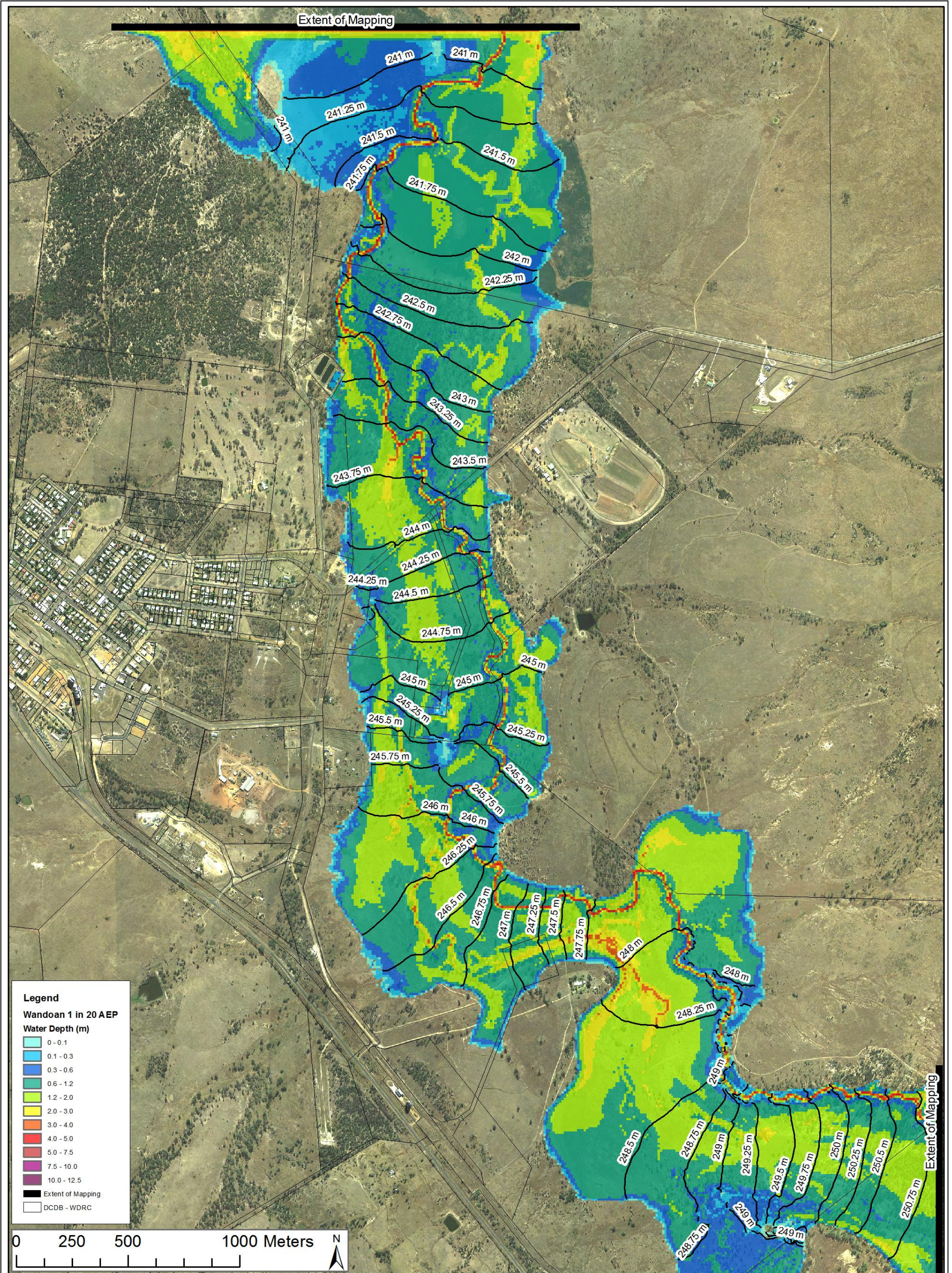

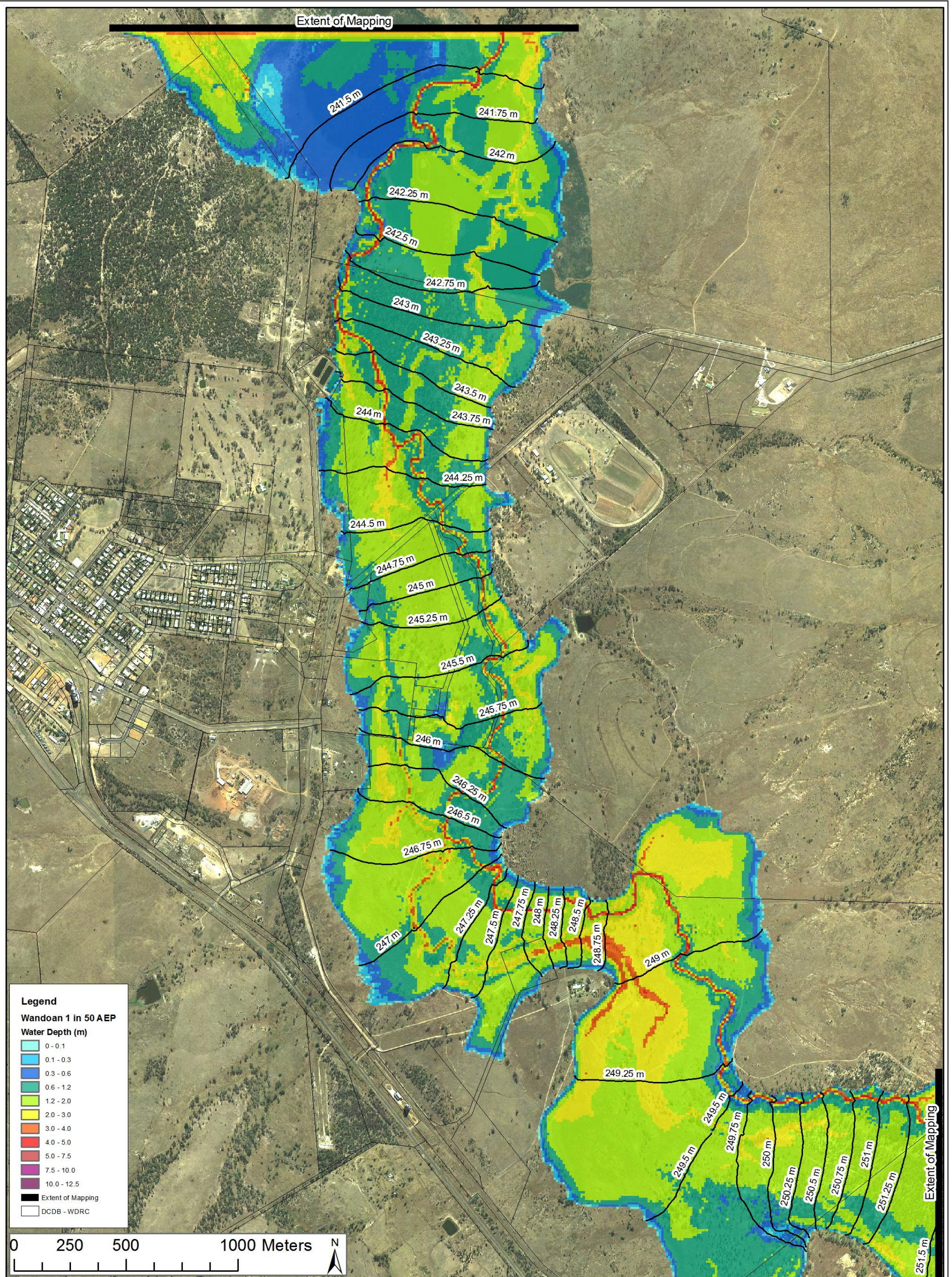

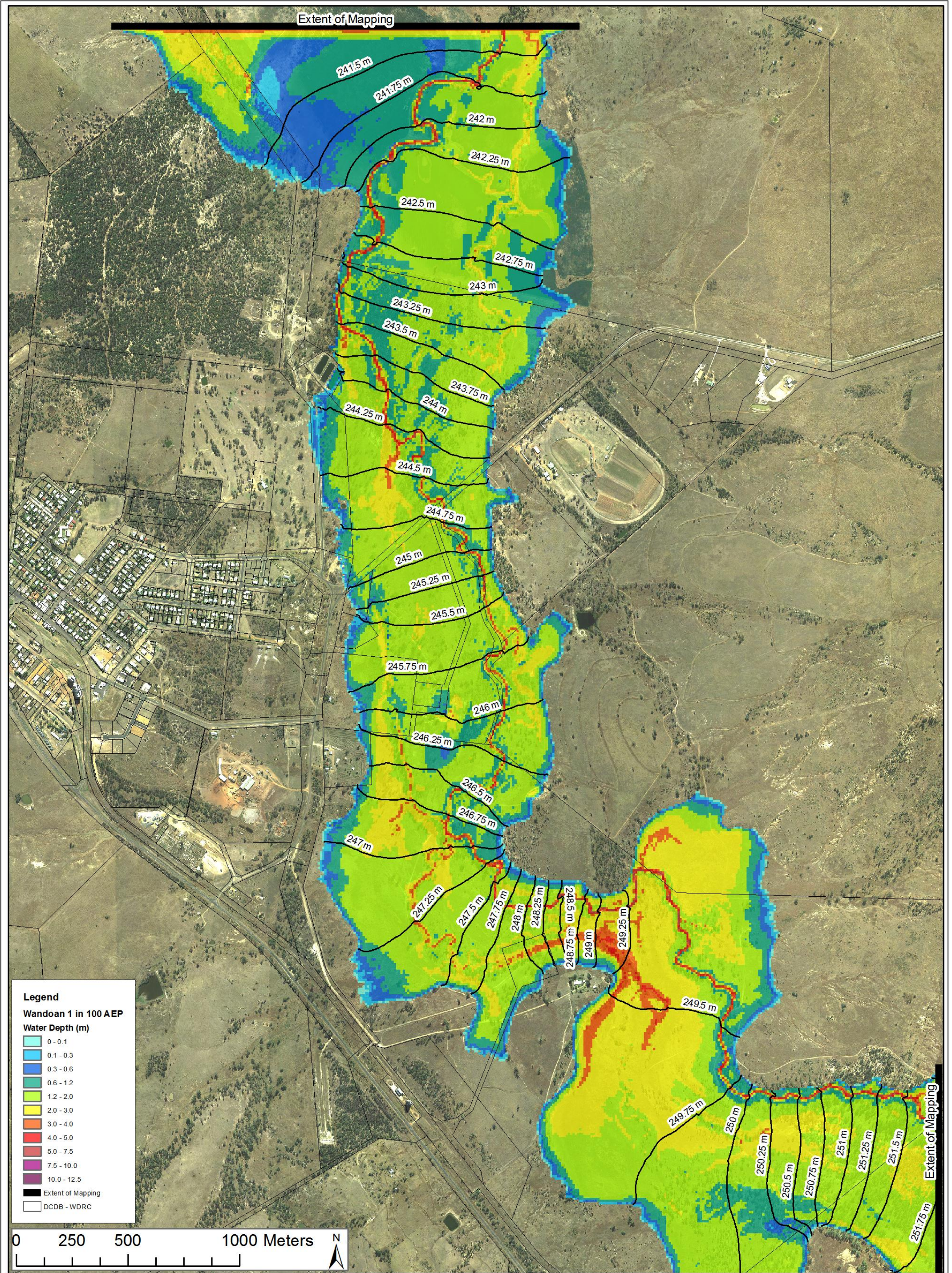
Wandoan 1 in 10 AEP Riverine Flood Extent and Depth

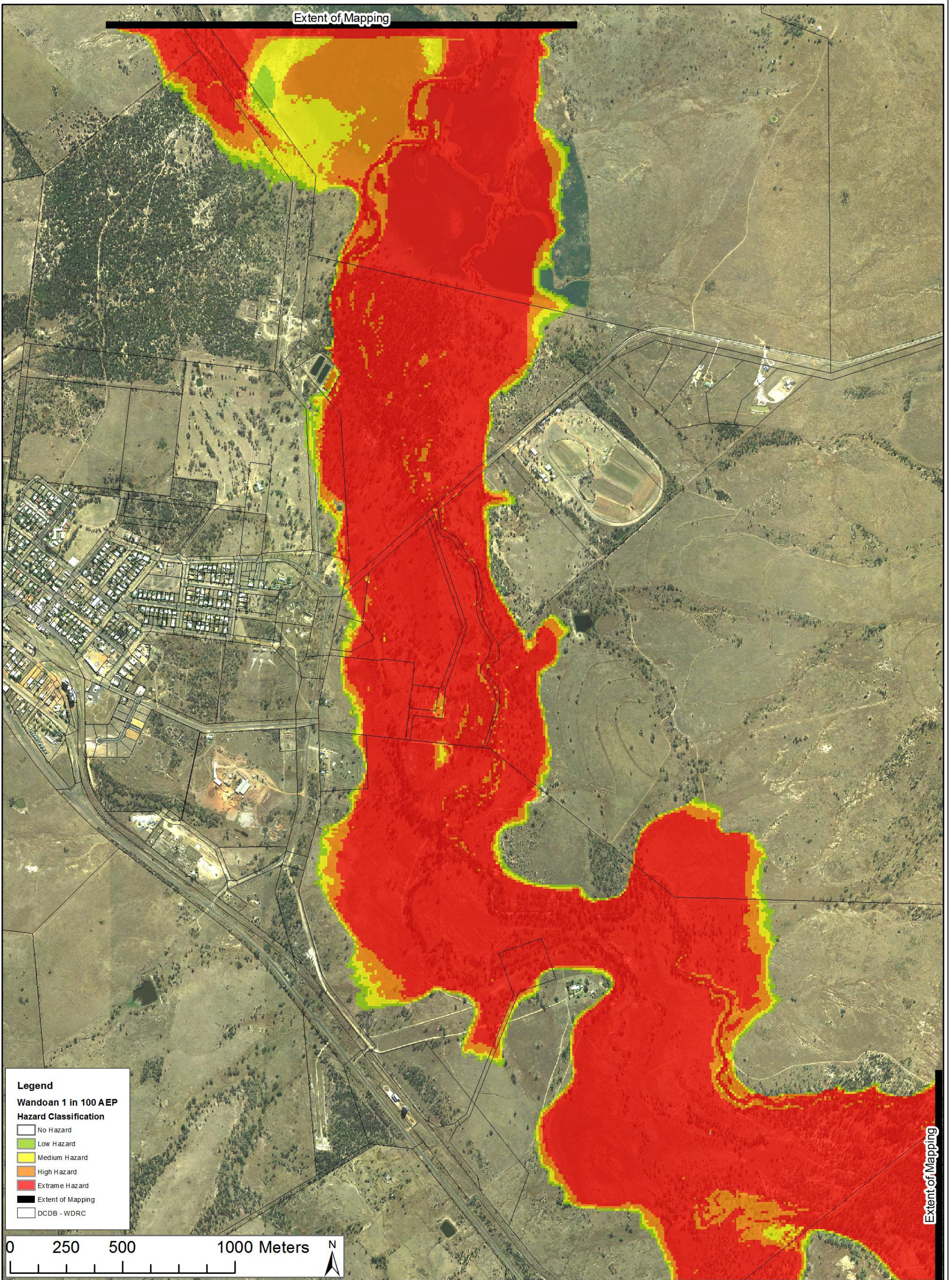

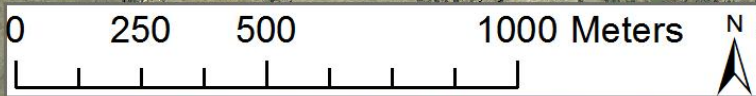

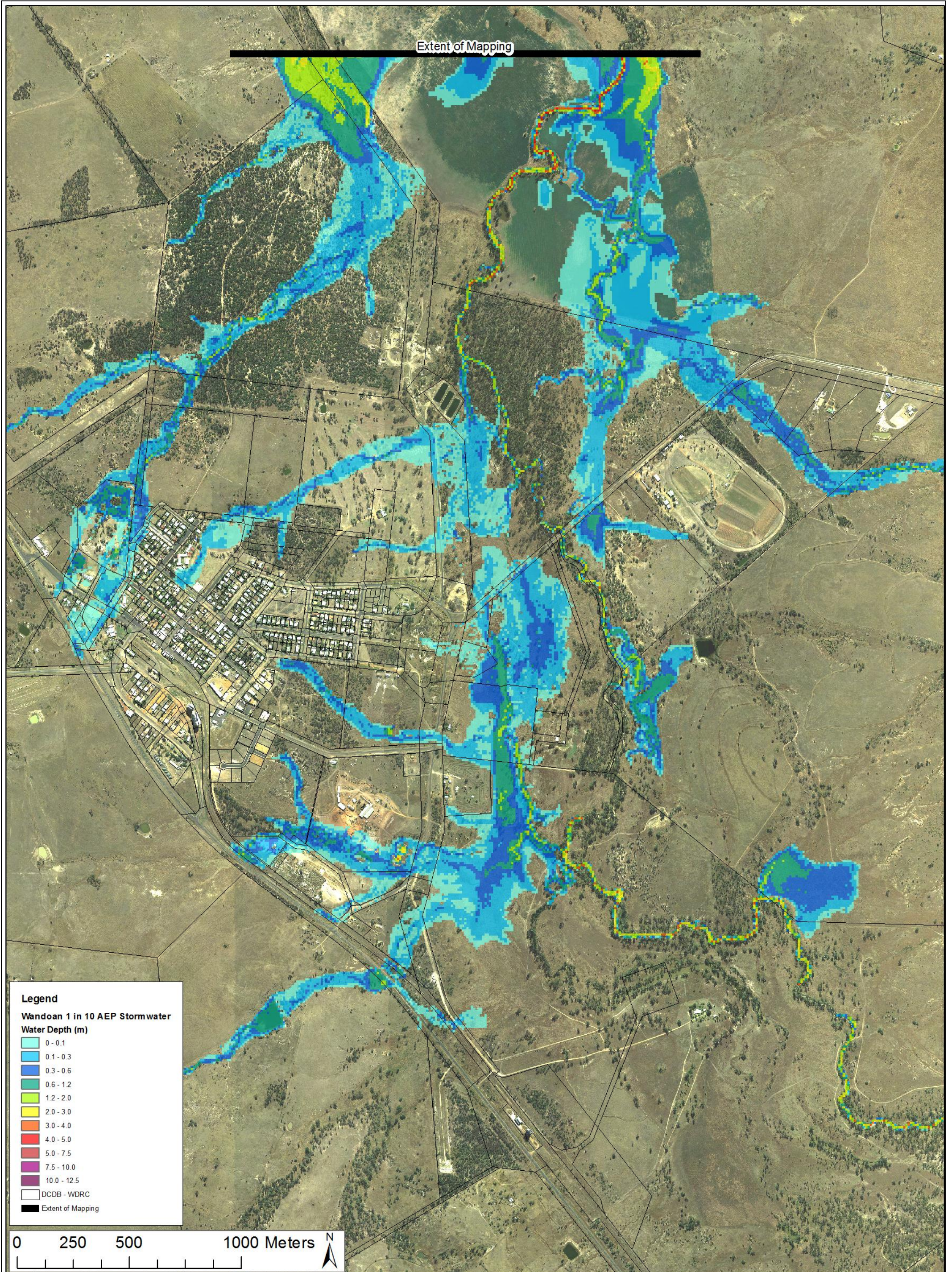

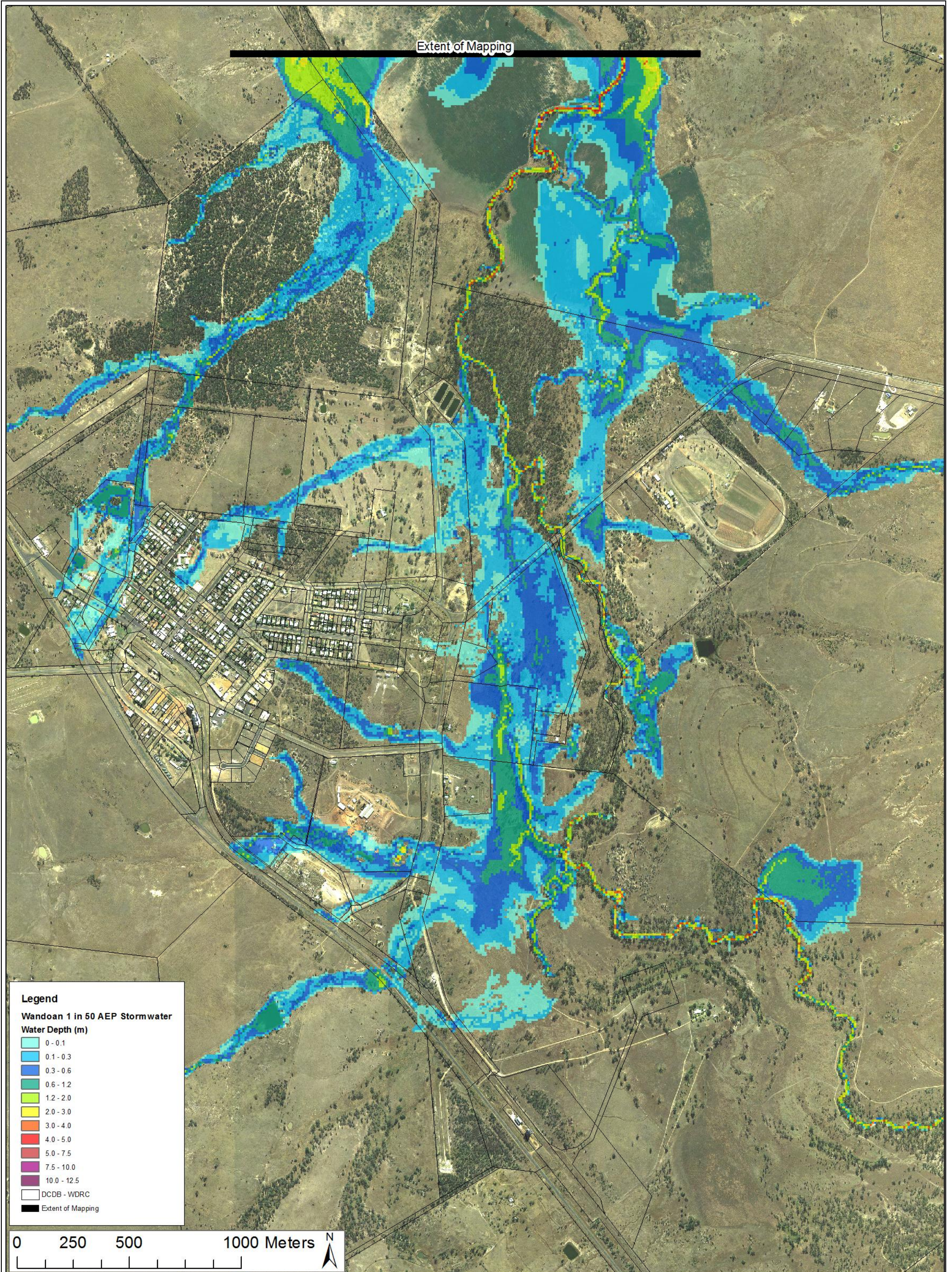

Map 5 Wandoan 1 in 100 AEP Riverine Flood Hazard

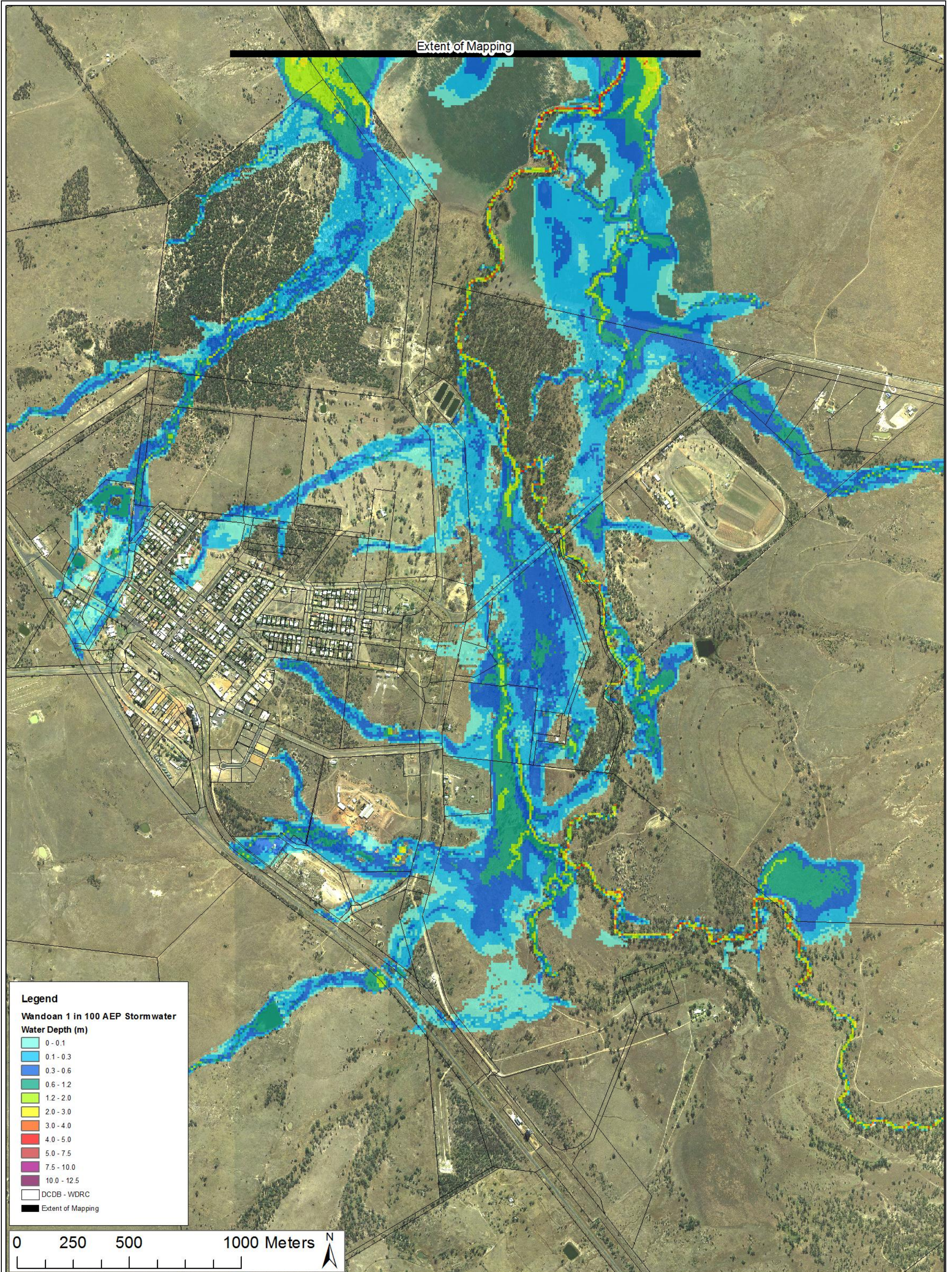




Map 6 Wandoan 1 in 10 AEP Stormwater Extent and Depth
