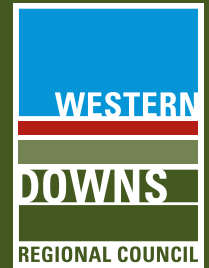


Council's waste disposal fees

Commercial & Industrial - Mixed (C&I) (Includes waste cooking or motor oil from non-domestic sources)	m ³	\$ 68.00
Commercial & Industrial - Paper & Cardboard (Separated and free of contamination)	m ³	\$ 25.00
Commercial & Industrial - Greenwaste, Clean Timber & Mulch Waste (Excludes minor quantities of non-woody waste and must be contamination free, including any treatment chemicals. Contaminated or treated timber will be classed as C&D)	m ³	\$ 25.00
Commercial Construction & Demolition (C&D)	m ³	\$ 140.00
Domestic waste (Self Haul) (Includes clean domestic green waste and clean untreated timber)	m ³	No charge
Domestic Construction & Demolition (Includes treated timber from a C&D activity) (No charge for minor quantities < 240 litres. Self Haul by vehicles no larger than Car/ Utility/ SUV and Trailer)	m ³	\$ 75.00
Recyclables (Separated & Contamination Free) Scrap steel, batteries, domestic waste motor oil - maximum 3 x 20 Litres	n/a	No charge
Concrete - (Clean & > 40mm) (Fee determined by largest piece of concrete. No charge where all pieces are crushed and <40mm)	m ³	\$ 128.00
Special Burial - Dead animals, confidential papers, etc.	m ³	\$ 68.00
Special Burial - Contaminated Soil (Subject to landfill acceptance criteria, may involve waste tracking by a licenced transporter)	m ³	P.O.A
Uncontaminated Clean Soil (With prior consent) (No charge where a site operational need exists for the material. Otherwise Construction & Demolition fees apply)	m ³	P.O.A
Minimum Charge for above categories	each	\$ 17.00
Tyres (Recycling fee per tyre from non-commercial source only. Tyre types not fitting these categories will be charged at C&I disposal rates.)	<ul style="list-style-type: none"> - Motorbike/ Car - Light Truck/ 4WD - Heavy Truck - Tractor / Grader 	each \$ 8.80 each \$ 16.60 each \$ 39.50 each \$ 179.30
Rim (still attached to tyre) or Contaminated Tyres (i.e attracts disposal surcharge) (Fee is in addition to the applicable tyre fee)	each	\$ 10.80
Mattresses (from a Domestic Source) (Fee not applicable for ensemble base, blow up and thin camp mattresses)	1st mattress each after 1st	No charge \$ 17.30
Mattresses (from a Commercial Source) (N.B. Other waste from commercial sources incur C&I charges)	each	\$ 17.30
